The Institute of Chartered Accountants of India (ICAI) is a statutory body created by the Chartered Accountants Act, 1949, passed by the Parliament of India. Chartered Accountancy is the highest professional qualification in the field of Accountancy in India.

The membership of the Institute is similar to the CPA qualification of the American Institute of Certified Public Accountants and Chartered Accountant degree of the Institute of Chartered Accountants in England and Wales.

101 Universities in India as well as the Association of Indian Universities and 6 IIMs (Indian Institute of Management) accept the Chartered Accountancy qualification as equivalent to a Master's degree for a Doctoral Programme.

The Chartered Accountancy Course in India involves a unique blend of practical training for a period of three years (for Intermediate/Professional Education - II/Integrated Professional Competence Examination/Intermediate(IPC) Examination stream students) or three and half years (for Professional Competence Examination stream students) under a practising Chartered Accountant as well as simultaneous theoretical education as a student of the Institute.

Ms. SUJATA LAKSHMINARAYAN IYER has served her articles for a period of three years and completed her practical training requirements under the Chartered Accountants Regulations, 1988.

Marks are awarded on a percentage scale. The Institute does not award Grades or Divisions but only has a pass/fail form of grading. To pass a group, a candidate needs to score at least 40% marks in each paper of the group and 50% marks in the aggregate of all papers in that group.

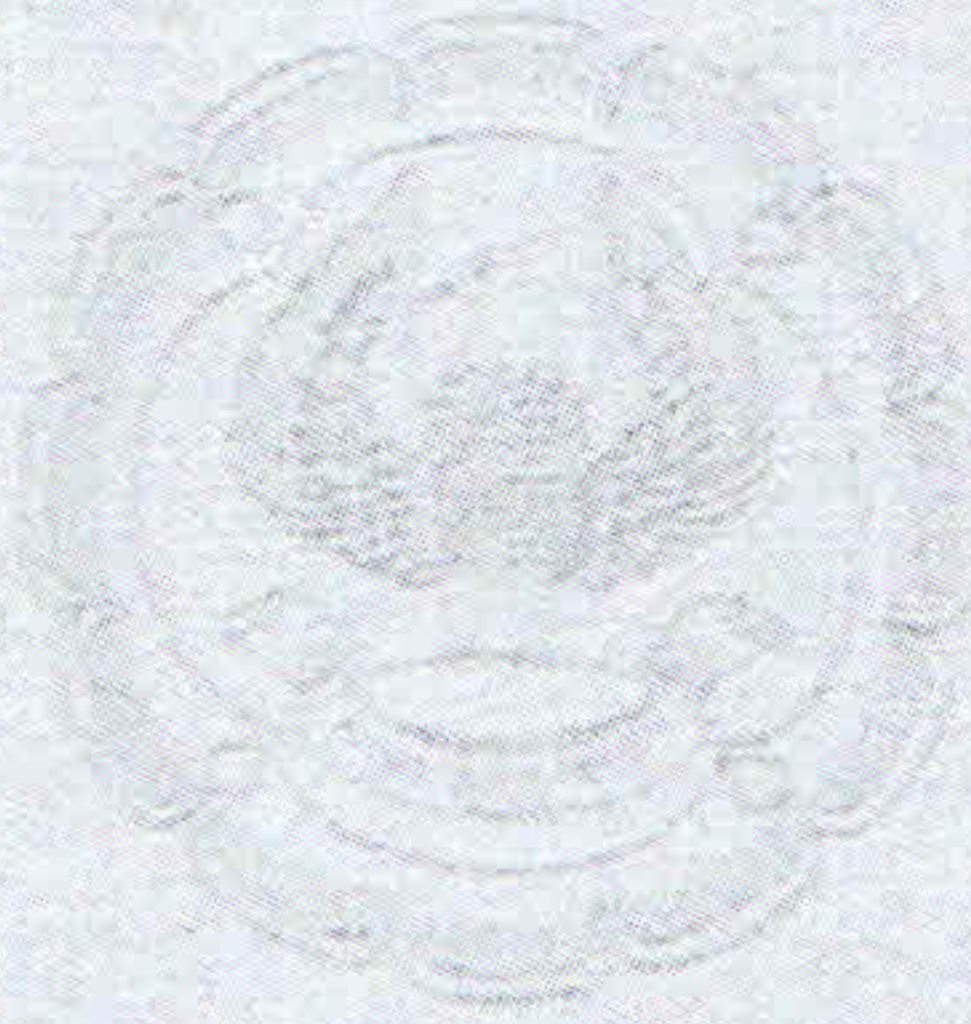

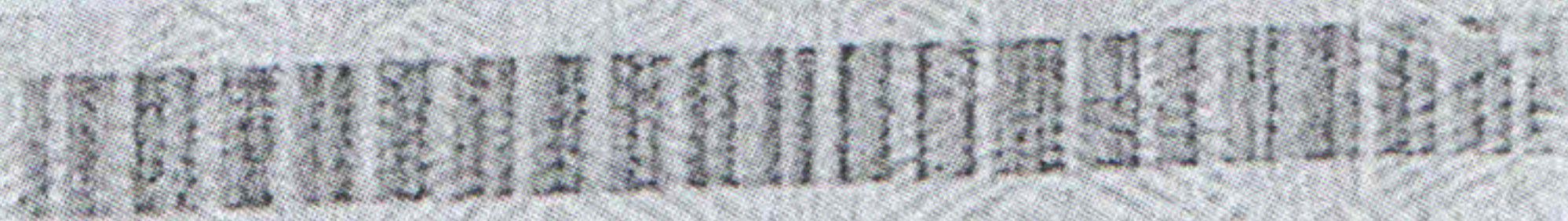
