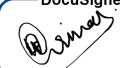

Terms and Conditions:

1. If you are being sponsored by a company, organization, or charitable trust, you must provide us with a sponsor letter (financial guarantee) before or when you register, otherwise you will be deemed a self-funded student responsible for paying your fees.
2. The tuition fees are fixed for the duration of the entire course as mentioned on the admission confirmation letter and will be due and payable upon acceptance of this offer letter. The installment payment pattern is only for the facilitation of fee payment and the outstanding installment amount cannot be considered as the only amount due.
3. The amount of the tuition fees for the entire duration of the program will become due upon acceptance of the offer, but the payment of the same can be made in flexible installments as stated in the installment schedule of the fee structure. Upon cancellation of admission without completion of the course, the remaining fees for the entire duration of the course will become payable with immediate effect irrespective of the installments.
4. Upon cancellation of admission or cancellation of the residence visa sponsored by BIUC, the tuition fees for the entire program will become due and payable immediately, and the cancellation will not be processed further until the same is paid. There will be no refund of tuition fees or any other charges in case of cancellation under any circumstances. All cancellation charges will become payable and will have to be borne by the student. Your seat for the course and intake has been reserved upon issuance of this offer letter; hence any fees paid are non-refundable upon cancellation for any reason.
5. The specialization modules will be taught by global faculties using online asynchronous and synchronous hybrid teaching methodologies.
6. All Euclea Business School qualifications are mapped to the relevant Répertoire National des Certifications Professionnelles (RNCP) at a level corresponding to your current qualification enrollment. This mapping ensures that the qualifications are benchmarked to the French qualification framework.
7. If you wish to apply for equivalency through UK ENIC (formerly UK NARIC) or WES, please contact the BIUC administration. The process for equivalency applications will be initiated by the Euclea campus in France.
8. Additional charges will apply for the equivalency process and issuance of RNCP certification
9. Other Payment Terms:
 - The 1st installment must be paid within 2 weeks from receiving the Admission Confirmation.
 - The conversion rate for international fees is considered as USD 1=AED 3.67 and is subject to change as per our policy.
 - Other fees (as applicable): Student Visa & Medical Insurance is USD 1,100, Student Visa Deposit is USD 900, Equivalence Fee is USD 275 and Student Visa Cancellation fee is USD 400. Please refer to the detailed schedule of charges to know about all the other fees applicable for specific services
 - Other conditions: If you have applied for a student visa, and you are unable to enter the UAE due to travel restrictions, you may be able to commence your studies online. In case you must undertake studies online due to any restrictions, you cannot claim any refund of fees paid or reduction of fees.
 - All the other terms and conditions of Britts Imperial University College shall apply. Please refer to the detailed applicable terms and conditions document.
