Visa and Travel History

After completion of my graduation, I was planning to go to the United Kingdom. Then I met an abroad consultant. He offered me Post Graduate Diploma in Business Management Programme. I accepted the offer. Then I received college letter. So, I prepared my file and placed my file at VFS Center, Ahmedabad on dt.10.01.2011. Then I received Tier-4 General Student Visa for U.K. on dt.21.01.2011. It was for the period from Dt.21.01.2011 to Dt.16.05.2012. My course was going to start from dt.14.02.2011. I departed from India on dt.11.2.2011 to reach at the Heathrow Airport. I landed on the soil of England on dt.12.2.2011. Then my course started on dt.14.2.2011. My joining date was 14.2.2011. I was attending the college regularly. Then after, because my grandmother was very ill, I was called upon back to India. Permission to go back was given from the college over the telephone. I came back to India on dt.30.8.2011. I passed 3 months in India. Then my grandmother expired. I went back to U.K. on dt.25.01.2012. After arriving at UK, I visited college 2-3 times during Dt.27.1.2012 to Dt.30.1.2012. I found college closed. I thought that there may be holidays in the college. Afterwards, I found that college was permanently closed. I paid 4900 Pound fees which were not received back and my degree remained uncompleted. Then I contacted its home office. Home office informed me that your Visa is not still cancelled and you have to file new application in the university and it is to be completed immediately. So, I tried for many universities. I was able to get admission. But fees in these universities were between 12000 to 16000 pounds. I was not able to afford that much fees. So, I contact local consultant there. He gave me new offers. He took my passport and other documents as well as 2900 pounds as fees and told me that when I will receive biometric call, you have to go the post office. I waited for long. Then I called him many times. Then I found that that person was a fraud. I even not received back 2900 pounds. But he send back my passport and other documents at my address. I inform about this incident at home office in person. Then Home office given me a separate visa for the period Dt.3.2.2013 to Dt.21.9.2013 for admission. Then after, I not received any reply. I tried many times. But I was being informed that your work is under appeal. Then I met to the solicitor. I handed over my documents to him as he asked. He pushed my work ahead. On Dt.29.10.2013, I was called upon for my personal interview. I informed them my all matters to them. I also told them that I want my fees return back. They accepted my request and continued my appeal ahead. Then I waited for the period Dt.19.10.2013 to 21.1.2018. Then office staff told me that there is no any data file of Sandip Girish Keshwala. They informed me to my solicitor that data files which is having data of 63000 persons is missing. So, I felt myself in depression. I also went to the hospital for the check up due to this reason. I was giving volunteer services there in L&D Hospital. I was given sum of pounds in cash & hand services there. I was living there with my maternal uncle. So, I received their free accommodation. Then again I finally met to my solicitor and asked him about what happened? He told me that "I should go back to India and give IELTS examination there and put your application for new file again. Home office will give you Visa 100% sure because you have given regular interviews at home office and also signed there and Home office has given you permission to go India over the phone and there is no any remarks of Ban on your passport and any other documents and also told me that you can come back to United Kingdom again anytime after filing new application. So, you should go back to India." At last, I talked with Home

office on date : 16.2.2018. My solicitor sent my tickets and other documents to the Home office. I was let go to India with full security and without any ban.

After coming back to India, I thought that my 8 years has gone in vain in UK. Now I want to study in any reputed university and want to make my career. So, I am filing this application. I hope that my admission is to be accepted and I receive call letter. This is my travel and visa history facts. All description mentioned above is 100% true.
